Student data:

Mr. Fugate discussed that MAP testing for grades 3-6 has been completed. Teachers are identifying the students not meeting benchmark and are beginning progress monitoring.

The council discussed that the field trip for the students scoring proficient or distinguished on KPrep for the 2016-2017 school year needs to be finalized. He stated that the scores were still embargoed but ideas need to be finalized so the trip can take place when the scores are released to the public.

Academic Success (RTI/Enrichments):

Mr. Fugate discussed that MR-C will be reaching all students. Instead of just focusing on the students that have not met benchmark (RTI), students who have met benchmark will also be receiving enrichment activities in the classrooms. This allotted time each day will be called Academic Success.

Academic Success for math will be daily for grades 3-6 from 9:00-9:30 using ALEKS math program. This 30 minute block will focus on Tier 1, 2, and 3. Teachers will closely monitor Tier 3 students.

Academic Success for reading will be daily for grades 4-6 from 10:00-10:30. During this time, students who have met benchmark will become MR-C Reading Buddies and will go to grades K-3 and reading with the students for 3 days and the other 2 days they will be involved with novel studies/writing activities. K-3 Academic Success will be from 8:15-8:45 using leveled groups.

CSIP:

Mr. Fugate discussed each teacher will be given a copy of the relationship building and asked to complete each section, giving documentation for each subsection. This will be discussed during the regular Wednesday planning coaching meeting with the teachers.

Grade Cam:

The council discussed the Grade Cam. Mr. Fugate discussed that this program had been purchased and will be tied to Infinite Campus and will graph data. He estimated that the program should be ready to use by October. A one hour Web Cam training will be conducted as soon as the program is ready to use.
